1. I accept for use, as is, the equipment (if any) listed on this form and accept full responsibility for its care while it is in my possession. I agree to RELEASE, FOREVER DISCHARGE, INDEMNIFY, DEFEND and HOLD HARMLESS Releasees, as described below, for all loss or damage I may cause to this equipment, except for reasonable wear and tear.
2. I understand that the engaging in the use of the Zipline, snowtubes, ice skates, snowshoes and cross country ski equipment, related equipment and climbing walls are HAZARDOUS ACTIVITIES. I further understand that engaging in these activities involves risk of injury to any and all parts of my body. I understand that there are numerous risks and dangers inherent in the use of snowtubes, ice skates, snowshoes, cross country ski equipment and climbing walls includes but is not limited to: variations in weather, surface, snow, ice and equipment conditions, falling, tripping, slipping, entanglement, being struck by equipment, failure to ski, tube, slide, climb and/or ride safely, collisions with other users, the ground or other objects, misuse or failure of the facilities or equipment, injuries to the head and other parts of the body including: broken bones, sprains, strains, dislocations, lacerations, slivers, abrasions, rope burns, punctures, acceleration or deceleration injuries, emotional trauma and death. There are also natural, mechanical and environmental conditions and risks, associated with zipline activities, which independently or in combination with my actions, or the actions of others that may cause severe or even fatal injuries to me or others. I understand that having an employee present does not lessen the amount or severity of the risks of these activities. I understand that I may suffer injuries and/or death by using the facilities, equipment and premises and that the RELEASEES are not responsible for my safety in any way and under all circumstances.

I hereby freely and expressly assume and accept the responsibility for any and all risks of injury or death while participating in these activities or related activities, while using the equipment and/or facilities, or while present on RELEASEES' premises, and I agree to RELEASE, FOREVER DISCHARGE, INDEMNIFY, DEFEND and HOLD HARMLESS Loon Mountain Recreation Corporation, their parent, subsidiary, affiliated and successor companies, real and personal property owners, directors, officers, agents, employees, as well as the equipment manufacturers and distributors, hereafter "RELEASEES" from ALL LIABILITY FOR NEGLIGENCE and any and all losses, damages, costs and attorney's fees resulting from any and all claims or suits for personal injury, death and/or property damage that may in any way arise out of my participation in these activities, related activities, or my use of the equipment and facilities, or my use of or presence on RELEASEES' premises, regardless of how or by whom or by what the personal injury, death and/or property damage was caused. I promise not to bring a claim against or sue the RELEASEES and agree that if anyone is injured or property is damaged while I am using the RELEASEES' facilities, I will have no right to make a claim or file a lawsuit against the RELEASEES, for any reason and under all circumstances.
5. **I AGREE TO RELEASE, FOREVER DISCHARGE, INDEMNIFY, DEFEND, AND HOLD HARMLESS THE RELEASEES FROM ANY AND ALL CLAIMS, SUITS, COSTS AND ATTORNEYS FEES FOR DAMAGE AND PERSONAL INJURY TO ME OR MY PROPERTY RESULTING FROM THE NEGLIGENCE ACTS OR OMISSIONS OF THE RELEASEES. I UNDERSTAND THAT THE RELEASEES ARE NOT RESPONSIBLE FOR THE CONSEQUENCES OF THEIR OWN NEGLIGENCE, THAT IS, THEIR FAILURE TO USE REASONABLE CARE IN ANY WAY.**
6. I understand that this agreement shall be binding upon my heirs, executors, administrators, and assigns and shall be governed by the applicable laws of New Hampshire. I also understand that if any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect. I agree that any claims that I may bring against the RELEASEES shall be submitted to the jurisdiction of the State or Federal Courts of New Hampshire and that no claims against the RELEASEES shall be brought in any other jurisdiction. I agree that there have been no warranties, expressed or implied, which have been made to me, which extend beyond the description of the equipment listed on this form.
7. I hereby grant permission to the RELEASEES to use my image(s), pictures or other likenesses, whether video, digital or print, for commercial purposes, or otherwise, without restriction as to frequency, duration or medium.
8. I understand that permission to use RELEASEES facilities, equipment and premises is being given to the undersigned participant in exchange for the execution of this Liability Release and Agreement Not to Sue.
9. I have read the above paragraphs and fully understand them. I understand that this is a RELEASE OF LIABILITY which will legally prevent me or any other person from filing suit or making any other claims for damages in the event of personal injury, death or property damage. I freely and voluntarily enter into this agreement. I have made no misrepresentations to the RELEASEES regarding my name, age, or medical condition. I intend this document to be interpreted as broadly as permissible by New Hampshire law and understand that it is not intended to assert any claims or defenses prohibited by law.
